Another year has passed and it is never too early to get a head start on your personal tax return. We thank you for your business and look forward to serving you again this year.

We would like to advise that we will be implementing a general increase in tax preparation fees this year. The cornerstone to providing quality service is having quality people. The accounting industry is experiencing increased competition for staff and the current inflationary climate adds pressure to this situation. In order to attract and keep our quality staff we must keep pace. Assuming your return has the same complexity and substance as last year a **minimum fee increase of 25%** is expected. Getting Started

- Please complete the fillable 2022 tax checklist.
- Please use the secure portal link you received by email; upload your records and completed checklist.
- You can also submit with your records and 2022 tax checklist to admin@lorennancke.com
- Once we receive your 2022 records, we will send you a confirmation email.
- If you have questions or a special request, an accountant will get in touch with you once your documents are reviewed.
- In our continued efforts to be a paperless office, we will be providing a digital copy of your completed return through our secure delivery portal. You are required to sign the electronic filing form. We cannot transmit your taxes until you sign the effile form.

We encourage you to send your records digitally. If necessary, you can drop off your documents to either of our offices; North Vancouver or New Westminster. Our North Vancouver office has a drop off slot on the front door, available 24/7.

Important Deadlines	
March 13, 2023	Documents due from self-employed individuals
March 20, 2023	Documents due for employment and commission expenses, rental properties or stock transactions
April 6, 2023	FINAL deadline to guarantee preparation and completion of your tax returns. All returns are processed on a first-come, first-served basis. Every return is important to us. You can still submit your records after the deadline, but we are unable to guarantee completion by April 30, 2023.
May 1, 2023	Last day to file and pay your 2022 income tax return for most taxpayers to avoid arrears interest and potential penalties
